

KAIKANTEN RORBUER / FISH CAMP RØST BOOKING AND CANCELLATION POLICY

PAYMENT TERMS:

Kaikanten Rorbuer (Louisiann AS) requires a deposit in connection with booking.

When booking, a deposit of NOK 5.000 per cabin/boat will be demanded.

This deposit is non-refundable in case of cancellation, and must be paid to secure the validity of the booking. If not paid, then there is the risk that Kaikanten Rorbuer may cancel the booking.

The remaining payment for the booking will be invoiced with a due date no later than 60 days before arrival.

ORDER CONFIRMATION:

The booking is binding for both parts, and as soon as the deposit has been paid, the booking is considered confirmed. The person, or company, on which the booking is registered, is financially responsible for the entire booking, including any damage that may occur on Kaikanten Rorbuer's belongings during the stay.

CANCELLATION:

In case of cancellation less than 14 days before arrival, the customer will be charged 50% of the total booking. In case of "no show", the customer will be charged 100% of the total amount of the order.

ILLNESS/ACCIDENT:

The customer himself/herself is responsible for any costs due to accident, or illness during the stay. It is therefore highly recommended to take out a travel insurance prior to the trip.

ACCOMMODATION/BOAT:

The accommodation shall not be inhabited by more persons than specified and agreed upon in the booking-documents.

The same applies to the maximum number of people in our rental boats.

Guests are obliged to treat the rented accommodations and furniture, as well as boats and equipment, with careness, so that damage and unnecessary wear and tear are avoided.

Liability for damage may be put forward to the customer, if such is inflicted on buildings and fixtures, or boats with equipment.

Noise and unacceptable behavior in the guest-accommodation area, or anywere else in the fishing-camp's facilities, must not occur, and may in worst case lead to expulsion from the camp.

BOAT RENTAL AND FISHING:

When booking a boat, the customer confirms that he/she, or another guest in the group, has a valid boat-certificate, and/or was born in 1980 or earlier, and has sufficient boat experience to travel safely at sea. The customer also confirms his/her understanding of the norms, laws and regulations related to travelling at sea.

According to Norwegian law, the maximum quota per 2022 that is allowed for tourists to bring with them home, is <u>18 kg</u> fish, or fish-fillet.

Kaikanten Rorbuer / Fiskecamp Røst would like to make our guests aware, that when renting a boat from us, they are regarded as "representatives" of our Fish Camp, and that we thereby expect them to show responsible behaviour when travelling at sea, so that safety is maintained, and so that the camp's reputation in the local community is not weakened.
